#### **Terms and Conditions**

By entering the Razor Electrics competition ("the Competition"), you are agreeing to the following terms and conditions:

# WHO CAN ENTER?

Entrants must also supply their full name, age, address, daytime contact number and choose their preferred Razor Electric scooter and submit the entry as instructed. The two Razor Electric scooters include: the Razor E100 and Razor E300. A valid entry will be included in one (1) of two (2) pools of valid entries, one (1) pool for each Razor Electric scooter (each, a "Prize Pool").

- 5) Entries must be received within the Competition Period.
- 6) All entries are deemed to be received at the time of receipt by the Promoter and NOT at the time of transmission by the entrant.
- 7) Multiple entries permitted, subject to the following: each entry must be submitted separately and in accordance with entry requirements and must be substantially unique.
- 8) Entry details remain the property of the Promoter and will not be returned to the entrant. Entrants agree to grant the Promoter a perpetual and non-exclusive licence to use, distribute, broadcast and sub-licence their entries in all media worldwide and acknowledge that they will not be entitled to any fee for such use.

The one (1) entrant whose entry is judged to be the most creative and original out of all valid entries received in each of the two (2) Prize Pools will be deemed the winner of their Prize Pool and awarded the prize nominated in their entry. The Competition is a game of skill and chance plays no part in determining the winner.
- 22) The prize winners will be notified by telephone and in writing using the contact details given in their entry.
- 23) The judges' decision in relation to any aspect of the Competition will be final and no correspondence will be entered into regarding the result. The Promoter may in its absolute discretion deem entries invalid subsequently to a winner being notified or a winner's name being announced if it is discovered that the winner did not enter the Competition in accordance with these terms and conditions. In such circumstances, an additional judging will be conducted.

Method of validation (without limitation) will be determined by the Promoter in its complete discretion.
