### Terms and Conditions

### Entry into the Promotion

- 1 The Schedule above and all other entry instructions and prize information published by the Promoter form part of these Terms and Conditions. Each Entrant agrees and acknowledges that they have read these Terms and Conditions (and Schedule) and that entry into the Promotion constitutes acceptance of these Terms and Conditions (and Schedule). All capitalised terms used in these Terms and Conditions have the meaning given in the Schedule, unless stated or as the context otherwise provides.
- 2 Entry is not open to:
  - a) directors, management, employees, officers and contractors of:
    - i. the Promoter,
    - ii. the Promotion Sponsor,
    - iii. the Prize Supplier,
    - iv. any related bodies corporate of the Promoter, the Promotion Sponsor and the Prize Supplier, and
    - v. the agencies and companies associated with the Promoter or the Promotion; and
  - b) a spouse, de facto spouse, partner, guardian, parent, child or sibling (whether natural or by marriage or adoption) of any person set out in clause 2a).

#### Entry material

- they will fully indemnify the Promoter against any loss or damage suffered by the Promoter: b) i. if any of the warranties given by the Entrant are false;
  - ii. as a result of any breach of clauses 8 and 9 of these Terms and Conditions by the Entrant: and
- c) they have express consent from each person appearing in the entry material (or if a person appearing in the entry material is under the age of 18 from that person's parent or legal guardian) and the owner of any private property (including any items, objects or real property) appearing in the entry material.

#### Winners

- 13 The Winner will be determined from all valid and eligible entries received during the Promotional Period in accordance with the Winner Determination. The Winner will receive the Prize.
- The Winner will be notified in accordance with the Winner Notification. 14 15
  - All reasonable attempts will be made to contact the Winner. If the Prize is:

    - b) forfeited for any reason.

#### General prize terms

- 16 All Prize values are correct and based on the recommended retail value at the Start Date of the Promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter, its associated agencies and companies and those agencies and companies associated with or involved in the Promotion (including each of their respective directors, officers, employees, servants, contractors and agents past and present) exclude all liability (including negligence), for any personal injury or death; or any loss or damage: whether direct, indirect, special or consequential (including loss of opportunity and loss of profit), arising in any way out of the Promotion or the Prize/s.

- 42 The Promoter reserves the right to take any action necessary in its sole discretion at any time.
- 43 If there is a dispute concerning the conduct of the Promotion, the decision of the Promoter is final and binding on each Entrant and no correspondence will be entered into.
- Prize/s and participation in this Promotion may be subject to additional terms and conditions 44 imposed by third parties. Entrants and Winners must comply with any such additional terms and conditions. The Promoter does not accept any responsibility and is not liable for any additional conditions imposed on the taking of a Prize or participation in the Promotion.
