Terms and Conditions

Entry into the Promotion

 - a) directors, management, employees, officers and contractors of:

 - c) they have express consent from each person appearing in the entry material (or if a person appearing in the entry material is under the age of 18 from that person's parent or legal guardian) and the owner of any private property (including any items, objects or real property) appearing in the entry material.

Winners

 - ii. participate in any promotional activity in connection with the Promotion or the Prize;
 - b) the Promoter may use their name, image, comments, photographs or audio-visual clips

- (**Materials**) for publicity and promotional purposes in any form of media, without reference or compensation to the Winner/s and their guest/s or any other person;
- c) the Promoter may use, reproduce, edit and communicate to the public the Materials at any time in any form of media;

and binding on each Entrant and no correspondence will be entered into.

imposed by third parties. Entrants and Winners must comply with any such additional terms and

relevant State authorities.
- 51 Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of
those rights.
- 52 These Terms and Conditions and the Schedule constitute the entire terms and conditions between
each Entrant and the Promoter with respect to the Promotion. The Promoter may alter, modify, or
amend these Terms and Conditions and the Schedule, subject, where relevant, to the approval of
the authorities that have issued permits or authorities for the conduct of the Promotion.

Privacy

- 53 The Promoter is bound by the Australian Privacy Principles in the *Privacy Act 1998*. The Promoter
will collect Entrants' personal information in connection with this Promotion and will use and handle
