## **Entry material**

9 Entries must be submitted in accordance with the Entry Method and must not be incomplete or incomprehensible.

## **Winners**

10 The Number of Winners will be determined from all valid and eligible entries received during the Promotional Period in accordance with the Winner Determination. The Winners will receive the Prizes.

11 The Winners will be notified in accordance with the Winner Notification and the Winners details (first initial, surname, postcode and State/Territory of residence) will be published in accordance with the Winner Publication.

12 All reasonable attempts will be made to contact the Winners. Subject, where relevant, to any direction given under the relevant State/Territory permit regulations, if a Prize is:

- b) forfeited for any reason,

## **General prize terms**

- c) to the extent relevant to the Promotion, the Promoter agrees and each Entrant must agree to adhere to the prevailing terms and conditions of each Platform Operator;
- d) Entrants understand that they are providing their information to the Promoter and not to the Platform Operator;

- f) any questions, comments or complaints about the Promotion must be directed to the Promoter not the Platform Operator.

### Limitation of liability

- 35 Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010*, as well as any other implied warranties under the *Australian Securities and Investments Commission Act 2001* or similar State and Territory consumer protection laws (**Non-Excludable Guarantees**). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter, its associated agencies and companies and those agencies and companies associated with or involved in the Promotion (including each of their respective directors, officers, employees, servants, contractors and agents past and present) exclude all liability, for any personal injury or death; or any loss or damage; whether direct, indirect, special or consequential (including loss of opportunity and loss of profit), arising in any way out of the Promotion or the Prizes.

  - a) any technical difficulties or equipment malfunction;

  - c) any delays or failures in any telecommunications services or equipment;

- 39 If for any reason any aspect of this Promotion is not capable of running as planned, including, without limitation, by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure, acts of God, civil unrest, strike, war, act of terrorism or any other cause beyond the control of the Promoter, the Promoter reserves the right in its sole discretion to cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a Prize, subject, where relevant, to any direction given under the relevant State/Territory permit regulations.

43 These Terms and Conditions and the Schedule constitute the entire terms and conditions between each Entrant and the Promoter with respect to the Promotion but they do not exclude the Entrant's rights that it would otherwise have under the *Consumer and Competition Act 2010 (Cth) (Australian Consumer Law)*.

44 The Promoter may alter, modify, or amend these Terms and Conditions and the Schedule where required by the authorities that have issued permits or authorities for the conduct of the Promotion or to otherwise comply with any other law. The Promoter will make reasonable attempts to notify each Entrant of any changes to the Terms and Conditions and the Schedule made pursuant to this clause.
